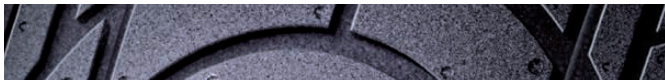
On the site, students can:

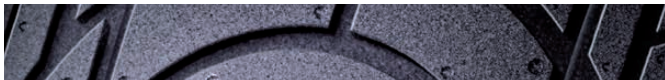
Visas and immigration

The British Council works closely with UK Visas and Immigration (UKVI) to help students, agents and audiences worldwide understand the UK's student immigration system.

- For students and parents – UKVI regularly give presentations and seminars at Education UK exhibitions and events. We also direct students to the UKVI website via the Education UK website and social media channels.

- For agents – The British Council works to train agents so that they understand the UK education system, visa and immigration requirements and are better equipped to advise and guide students who want to study in the UK. We make available a list of all agents who have passed our training course.

Sharing information and best practice

UK visas are managed by the UK government Home Office department – UK Visas and Immigration.

UKVI's Joint Education Taskforce (JET) and the Sponsorship Working Group (SWG) brought together UK education sector bodies – such as UKCISA, NUS, the British Council and other stakeholders – to help ensure that the student visa system works effectively for students, education providers and government alike. JET was replaced in 2015 by the Education Sector Forum (ESF), which is run by the Home Office rather than UKVI and the SWG has now finished.

Feedback on visa issues from our overseas offices and educational institutions in the UK are fed through to Home Office and UKVI senior staff, which helps to highlight the main issues worldwide. British Council staff in the UK and overseas are also trained and informed of all immigration rule changes and have access to an internal staff Education I Centre Visa Section where they have visa alerts, a publications library and access to podcasts.

The Home Office has reviewed official consultation documents and listened to our views and those of other ESF members at Home Office meetings and at meetings with government ministers. As a result of this feedback, a number of changes have been implemented to their policy guidance in relation to Tier 4 Policy Guidance.

We also provide evidence to parliamentary enquiries to support the passage of genuine international students to the UK including:

Safety in the UK

Safety in the UK for students, dependants and visitors coming to the UK is a duty of care we take very seriously and we all work together to help students and visitors

take care of themselves and settle happily into their local community. The British Council is represented on the National Student Crime Group and ProtecED Stakeholder Board and works closely with organisations in the UK to exchange knowledge, keep up to date with crime trends, legislation and other safety issues to help protect international students, their dependants and visitors to the UK against crime.

Tier 5 Government Authorised Exchange

The British Council has licences for a number of projects, under Tier 5 Government Authorised Exchange (GAE), to support specific UK government objectives. We offer colleagues (project managers) guidance and support with registering for sponsorship. We also maintain a database with details of all British Council Tier 5 projects, which includes dates licences were issued, rating, clients, key contacts and other 'sponsor management' roles.
